**INSTRUCTIONS**

- If you, either personally, or as part of a corporation, own land in the control area, you can cast one vote per acre of land.
- If you own less than one acre, you can cast one vote.
- If you have been granted or assigned the water right of land within the control area, you can vote in place of the person or corporation owning the land.
- **Only the votes which derive from within the district of the control area shall be cast in the election of that district's board member (see attached map).** For further information, please refer to W.S. 41-3-913 (c).

To vote, fill in the number of votes you are entitled to across from your choice of candidate.

To write-in a candidate not on the ballot, write the name on the line provided and fill in the number of votes you are entitled to across from the write-in line. Write-in candidates must be adults who own land or underground water rights, or who are the officer, official or member of the board of a corporation which owns land or underground water rights within the Control Area.
